

Analysis of IS3:

As can be seen from the analysis below, almost 90% of economic entities which report to the SEC using XBRL-based financial reports conform to the relation tested by rule IS3 which is:

Income (Loss) from Continuing Operations Before Equity Method Investments = Operating Income (Loss) + Nonoperating Income (Loss) - Interest And Debt Expense

However, there are 1,054 economic entities which report to the SEC using the XBRL-based financial reports which do not conform to this relationship rule, about 10% of all 9,679 entities.

Why do the 1,054 economic entities not conform? To determine why, information from each of the 9,679 reporting entities was loaded into a database so that the detailed information can be examined.

The information relevant to this question for every filer’s financial report was loaded into a database. A query returns the relevant information as can be seen from the screen shot below:

A query of the data set filters all 9,679 filers to a set of only those filers where the result of test IS3 does NOT equal ZERO meaning that the relationship expressed above is not satisfied. Note the total record count of 1054 which matches the testing summary above:

So a test is created in the query to show where InterestAndDebtExpense minus the IS3 result amount equaled 0, meaning that the two values (InterestAndDebtExpense and the result of test IS3) were equal.

This is that result. Note the total record count of 514. That means that there were 514 reporting entities who had the same pattern of information.

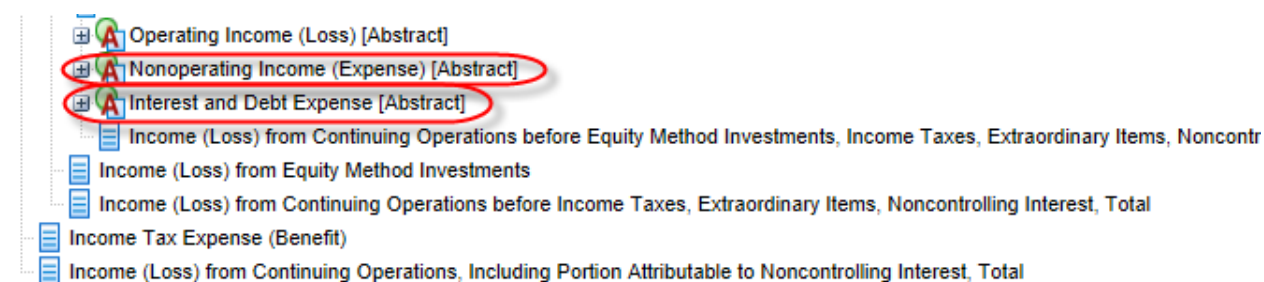

By examining the US GAAP XBRL Taxonomy you can see that the taxonomy defines *Nonoperating Income (Expense)* and *Interest and Debt Expense* as two different categories of concepts each of which makes up the difference between *Operating Income (Loss)* and *Income (Loss) from Continuing Operations*: (which line item exactly depends upon whether the filer reports *Income (Loss) from Equity Method Investments* or *Income Tax Expense (Benefit)*):



That the specific report above shows and what in fact each of the 514 entities where the amount of the difference between Interest and Debt Expense and the result of test IS3 (i.e. a “pattern”), of the total 1054 entities (about 50% of the errors) are because a filer reported Interest and Debt Expense as a part of Nonoperating Income (Expense).

The question one can ask is this: Is this approach to reporting appropriate? There appear to be exactly three possible conclusions which could be reached given the facts which exist for the situation which is being observed:

1. Filers are NEVER ALLOWED to combined “Nonoperating Income (Expense)” and “Interest and Debt Expense”. Over 90% of SEC filers never combined *Nonoperating Income (Expense)* and *Interest and Debt Expense*, this can be seen by examining SEC XBRL financial filings.
2. Filers ARE ALLOWED to combined these two concepts. That is what these 514 reporting entities are essentially doing by articulating Interest and Debt Expense as part of Nonoperating Income (Expense). However, the US GAAP XBRL Taxonomy clearly shows that the concepts they have defined are distinct concepts. And therefore, there is a concept missing from the US GAAP XBRL Taxonomy, “Nonoperating Income (Expense) including Interest and Debt Expense”, which should be added to the taxonomy to combined the two existing concepts into one concept. Then, filers could use that concept.
3. Filers can, as these 514 filers have done, change the relation between the concept Interest and Debt Expense, make it part of Nonoperating Income (Expense), and therefore the information expressed by these 514 filings is not in error. What this would imply is that any SEC filer can change the relation between any US GAAP XBRL Taxonomy concept to express any relation which they might desire.

Which is the correct conclusion? Are there perhaps other conclusions which could be reached? Perhaps there are. If #1 or #2 were deemed to be the correct conclusions, then machine interpretation of XBRL-based financial filings is possible. If #3 is the correct conclusion, then it will never be possible for machine-based processes to make use of the information from the 1,054 filings which have unknown relation patterns between the concepts: Income (Loss) from Continuing Operations Before Equity Method Investments, Operating Income (Loss), Nonoperating Income (Loss), and Interest And Debt Expense. Further, it would mean that issues caused by the other 21 fundamental accounting concept test results would cause machine-based processes to stumble and not be able to decipher or interpret reported information. But most importantly, it would mean that the same sort of inconsistencies which cause this one issue, and which cause other issues pointed out by the other 21 fundamental accounting concept relations, would likewise exist in the many, many, many detailed line items of the primary financial statements and within the other disclosures within the notes to the financial statements.

Could the information be read by machines? Yes it could. But after a human-based process and therefore a very expensive and time consuming process of mapping the correct interpretation of information, after a human deciphers and interprets and then creates machine readable information so that machines can then process the reported financial information. It is really that straight forward.

Remember, analysis/exercise shows ONE test of ONE relation. There are 22 such relations between fundamental accounting concepts. This question and answer to this question impacts not just this relation; and not just the 22 relations between fundamental accounting concepts; but rather it impacts every relation of every concept between every other concept in the US GAAP XBRL Taxonomy and in SEC XBRL financial filings. Thousands of disclosures are impacted by the answer to this question.

Therefore, chose your conclusion very carefully.

The following is a summary of SEC XBRL Financial filings which do not conform to fundamental accounting concepts relations test IS3 for the reason pointed out in the analysis above.
